The meeting was called to order at 10:03 a.m. by Senator Watkins, Chairman, who asked the Commission members to introduce themselves to the audience. Senator Watkins then recognized Hal Greer, JLARC staff Director, who provided a brief overview of the meeting agenda and introduced a new JLARC staff member to the Commission (Nick Galvin). Mr. Greer then introduced Mark Gribbin, Principal Legislative Analyst for Ongoing Oversight and Fiscal Analysis, who presented the Commission with an update on IT governance reform. Mr. Gribbin answered some questions of the Commission then introduced Eric Link, Executive Director of Legal and Legislative Services for VITA, who

provided the Commission with a progress report briefing on VITA's infrastructure sourcing. Mr. Link answered several questions of the Commission throughout his presentation. Subsequently, Senator Watkins invited Karen Jackson, Secretary of Technology, to provide some comments in response to Mr. Link's presentation.

Following Secretary Jackson's remarks, Senator Watkins introduced Martha Mavredes, Auditor of Public Accounts, to present the APA's review of prior year audit results. Ms. Mavredes answered a number of questions of the Commission throughout her presentation. Subsequently, Ms. Mavredes introduced Staci Henshaw, Deputy Auditor, who presented the APA's annual work plan and proposed salary scales. At the conclusion of Ms. Henshaw's presentation, the Commission did not have a quorum needed to vote on the approval of the APA's work plan and salary scales. Accordingly, Senator Watkins requested that the Commission wait to vote on these items at the beginning of the JLARC meeting in July.

Lastly, Mr. Greer announced that the next Commission meeting is scheduled for Monday, July 13, which will include presentations from VRS, following the approval of the APA's work plan and salary scales.

There being no further business, the Commission rose at 12:37 p.m.
