

### JLARC Meeting November 7, 2022 – MINUTES

## **Topic Selection Subcommittee Report**

Senator McPike gave a brief report on the potential topics discussed and the study recommendations being brought forward for the commission to vote on for 2023. Following his briefing, the Commission members voted and approved the following six studies: public safety occupation eligibility for enhanced retirement; state-operated inpatient psychiatric hospitals; effectiveness of self-sufficiency programs; availability and affordability of childcare; adequacy and availability of legal representation for indigent defendants and commonwealth's attorney staffing; supply of qualified individuals to fill K-12 teaching positions; and the Virginia Growth and Opportunity (Go Virginia) Program.

# Pandemic Impact on K-12 Public Education

Following, Mr. Hal Greer gave an overview of the meeting agenda and introduced Mr. Justin Brown, who gave an overview of the Pandemic Impact on K-12 Public Education report.
