






Update on State's Enterprise Resource Planning System – Cardinal

JLARC oversight of Cardinal

- Appropriation Act requires JLARC to oversee Cardinal on a continuing basis
 - Development, implementation, performance, and costs
 - Technology and security
 - Governance

What is Cardinal?

Cardinal is an Enterprise Resource Planning (ERP)
 system designed to integrate state's business functions



History of Cardinal project

- 2016 <u>Cardinal Financials</u> completed and replaced state's legacy financial system
 - \$111 million was spent on Financials project
- 2016 <u>Cardinal Payroll</u> initiated to replace state's legacy payroll system (CIPPS)
- 2018 Cardinal Payroll expanded to <u>Human Capital</u> <u>Management (HCM) project</u> after data conversion problems with legacy HR system (PMIS)
 - Includes replacing PMIS and BES
- 2021-22 Planned roll out of HCM to all agencies

CIPPS = Commonwealth Integrated Payroll/Personnel System.

PMIS = Personnel Management Information System. BES = Benefits Eligibility System.

HCM project costs (FY15-FY22)

Project	Spending
Payroll project (spending to date)	\$35.9M
Expanded HCM project (estimated)	\$85.9M
Oracle Cloud (estimated)	\$8.5M
Total HCM project costs (estimated)	\$131.8M

The HCM Project is being funded through a Working Capital Advance, which will be paid off over 10 years through the Cardinal Internal Service Fund.

Release of HCM application was delayed 6 months in early 2021

- HCM will be released to users in two waves
 - Users include state agencies and localities
- First wave was delayed 6 months from April 2021 to October 2021
 - Issues with converting data to new HCM application
- Second was delayed 6 months and rescheduled for April 2022

HCM project currently within overall budget and new schedule

- As of November 2021, HCM project is within budget and new schedule
- Released to first wave of users on schedule on October 2, 2021
 - HCM released to 18 state agencies and 3 localities
 - Project team working through data and user issues, but no major disruptions to payroll and benefits processing

Risks to Cardinal HCM project success

- Highly complex project incorporating multiple systems and state and local entities
 - Schedule slippage and costs from unanticipated problems
 - Prior delays have eliminated most scheduling contingency for remainder of project
- Challenges preparing agencies and localities to use new systems during COVID-19 pandemic

Future considerations for Cardinal

- Permanent governance structure needs to reflect <u>all</u> agencies' business needs
 - Affects decisions on whether/how to increase functionality of Cardinal
- Open procurement for Cardinal support in 2022
