





Potential JLARC study topics

Objectives

- Discuss additional potential topics to be studied in 2022
- Develop recommended list of study topics for Commission consideration and approval
 - Staff will develop draft study resolutions for recommended topics

2021 General Assembly assigned JLARC 3 reviews through joint resolution

- Assess the costs to implement the K-12 Standards of Quality (SJ 294)
- Impact of COVID-19 on Virginia's public schools, students, and school employees (HJ 549)
- Options to make income tax more progressive (HJ 567)

Subcommittee goal to select 2 new topics

- Staff has capacity to conduct 2 additional studies to be completed next year
- New, more pressing study topics that emerge during the legislative session can be prioritized ahead of assigned studies

Several bases or sources for topic selection

- Joint resolutions
- Studies already approved by JLARC study selection subcommittee, but not full Commission
- Referrals from other legislative committees or commissions
- Subcommittee member topics of interest
 - Programs, policy issues
 - Agencies not recently reviewed
 - Rotational review of functional areas of government (Legislative Program Review and Evaluation Act)

Study subcommittee identified topics not referred to full Commission for approval

- Effectiveness of inmate education and vocational training programs in Virginia's prisons and jails
- Effects of gun violence in Virginia and strategies to reduce gun violence
- Policing by police departments and sheriffs offices in Virginia localities and by the Virginia State Police

Note: Two additional topics related to the affects of the pandemic were also approved: (1) impact of pandemic on K-12 and (2) impact of pandemic on government more broadly.

Request to review DBHDS licensing practices

- Referred to JLARC by the Joint Subcommittee for Health and Human Resources
- Request to review DBHDS licensing regulations, policies, practices and requirements
- Ensure quality services
- Ensure fair and equitable treatment of providers seeking new or maintaining existing licenses

Member ideas prior to meeting

- Virginia's Community Services Boards
- number & structure
- service delivery across regions
- capacity and adequacy of services
- funding and cost of operations
- coordination with DBHDS and private sector

Potential programs & policy issues to review

- Evaluation of GO Virginia
- Effectiveness of rural economic development efforts
- In-patient mental health care
- Child Protective Services
- Adult Protective Services
- Higher education (funding, affordability, student debt, changing enrollment patterns)
- State government agility, adaptability, & responsiveness (regulatory, procurement, IT, employment & compensation)
