#### JLARC evaluation of economic development incentives

- Appropriation Act directs JLARC to evaluate economic development incentives on an ongoing basis
  - Spending and business activity
  - Economic benefits
  - Effectiveness


#### In brief

Virginia spent \$3 billion on 92 economic development incentives from FY13 to FY22.

Incentive spending increased between FY16 and FY21, but declined in FY22 because Micron received its final custom grant payment (\$50 million) and the coal tax credits were repealed in FY21.

A majority of the incentive programs adopted since 2017 have been custom grants, which are relatively large and account for a large share of incentive program funding.

### Ten incentives account for nearly two-thirds of spending on incentives (FY13-FY22)





### Increased incentive spending has been driven by exemptions, and more recently, grants

### Large custom grant awards in FY19 will lead to increased grant spending in future years (\$M)



Large custom grants awarded in FY19: Amazon HQ2 (\$750 million), Micron (\$70 million), and Amazon Web Services (\$10.5 million). The custom grant for Micron is the only one paid in full (\$20 million in FY20 and \$50 million in FY21); other custom grants will be paid out incrementally over time.


