Topic #1 – Presumptions for workers' compensation benefits

- Eligibility for compensation presumes that certain conditions arose from employment and entitles workers with those conditions to compensation
- Presumptions include respiratory disease, hypertension, heart disease, cancer, infectious disease (§ 65.2-402)
- Virginia Workers' Compensation Commission collects fees to finance program and adjudicates claims

Potential issues = Basis for current presumptions; process to identify and validate presumed conditions; process to determine fees paid by employers; impact of # and type of presumptions on fees.

Topic #2 – Department of Small Business and Supplier Diversity

- Coordinates and mobilizes efforts to help establish, preserve, and strengthen small, women-owned, and minority-owned business
- Certification of SWaM businesses, DBEs, ESOs, HBCUs, SDVs, and micro-businesses
- Business development and outreach services
- Loan assistance and grants

Potential issues = Agency mission; adequacy of program goals and program effectiveness; stakeholder satisfaction with services; efficiency & effectiveness of agency administration.

Topic #3 – Special education

- The Board of Education shall supervise each school division's special education program (§ 22.1-214.A)
 - Educate and train children with disabilities
 - Ensure a free and appropriate education to all children to meet their unique needs
- ≈150,000 school age children have qualifying disability or developmental delay
- \approx \$465M in FY19 (\$398M SOQ + \$68M regional tuition)

Potential issues = K-12 system's ability to provide adequate services under the law; legal and financial implications of not providing adequate services; costs and cost drivers; decisions regarding services in public vs. private settings; use of regional programs.

Topic #4 – Department of Education central office operations and performance

- Department of Education provides assistance as necessary for the proper and uniform enforcement of the provisions of the school laws in cooperation with the local school authorities
- ≈\$108M for central office operations (FY19)
- Allocated 330 staff positions

Potential issues = Adequacy of assistance to, and oversight of, school divisions; identification and development of strategies to address statewide K-12 challenges; internal agency efficiency and effectiveness; adequacy and allocation of internal agency resources.
