School Library Book Removals in Virginia

Senate Joint Resolution 251 (2025) directs the Joint Legislative Audit and Review Commission (JLARC) to survey school divisions about library book removals (Appendix A). JLARC worked with Virginia Commonwealth University's Survey and Evaluation Research Laboratory to administer the survey. JLARC also interviewed the Virginia Association of School Librarians, Virginia Parent Teacher Association, Virginia Association of School Superintendents, Virginia School Boards Association, Virginia Association of Elementary School Principals, and the Virginia Department of Education (VDOE).

Local school boards have authority over school library book removal

Local school boards have the authority to select and remove school library books. The Virginia Constitution grants each local school board supervisory and operational authority over local schools, including over school libraries and the books they contain. The state does not have authority over division selection and removal of library books under current law, and it does not provide divisions written guidance about it.

State law and regulations do, though, have some requirements related to school libraries. For example, the Board of Education requires each school to maintain a library that includes materials that are sufficient to meet the research, inquiry, and reading requirements of instruction and general student interest. Schools are also required to have library staff with certain educational qualifications.

More broadly, state law requires divisions to set policies related to *instructional* materials, which applies to library books only when required for a class assignment or educational program (sidebar). The Standards of Quality require each school board to set policies related to the selection and evaluation of instructional materials, to set procedures for handling challenged instructional materials, and to ensure the policy considers the views of teachers, parents, and other concerned citizens. However, state law does not require school divisions to have a specific policy relating to selection and evaluation of library books or challenges to library books when they are not instructional materials.

Most divisions have school library book removal policies

Most divisions responding to the JLARC survey have some type of policy about removal or "challenges" of school library books. Eighty-one divisions (88 percent of divisions responding) reported having a formal policy (sidebar, next page).

Instructional materials and library books. VDOE guidance states that "library materials are considered instructional materials when used (i) for completion of an assignment or (ii) as part of an academic or extracurricular educational program." Many instructional materials, including certain textbooks or virtual material, are not contained in school libraries. Conversely, many library books are not instructional materials.

In April and May 2025, JLARC surveyed school divisions about library book removals. Divisions were asked about their book removal policies and processes and the specific books removed since July 2020. Out of 131 divisions, 94 responded, a 72% response rate. These divisions educated about 1 million of the state's 1.2 million public K-12 students, or 84 percent.

Composition of non-responding and responding and responding divisions was generally similar. However, divisions were less likely to respond if they had ≈1,000 to 3,500 students. Divisions were more likely to respond if they were in the Central Virginia and the Blue Ridge & Valley regions.

These policies vary widely in level of detail and specificity. For example, some simply stipulate that decisions about book challenges are made at the school level, and decisions can be appealed to the school superintendent or school board. Other division policies are much more detailed, with some divisions adding specific requirements such as timeframes for reviewing book challenges, limits on who can challenge a book, inclusion of school-level *and* division-level review committees, and guidance about whether a challenged book may remain on library shelves while it is being reviewed.

At least half of the responding divisions appear to base their policies on a model book challenge policy developed by the Virginia School Boards Association (VSBA), though divisions have adapted and modified it to varying degrees. This model policy provides two options for school divisions to use. The most frequently used of the two

- requires that a complainant wishing to have a book removed fill out a specific form and submit it to the principal or central office;
- requires the principal to form a review committee that includes the principal, library media specialist, the classroom teacher (if involved), complainant, and parent and/or student; and
- allows the complainant to appeal the review committee's decision, first to the superintendent and then to the school board.

The vast majority of responding divisions' book removal policies have been updated in the last several years. However, three divisions reported having a policy that had not been updated in 15 years or more (2001, 2009, and 2010).

Most divisions have school library book removal committees

Regardless of their specific policies, about three-fourths of divisions responding to the survey have a group to review and make recommendations about whether to remove books from school libraries (typically formed in response to complaints as they are made). Sixty-seven divisions (73 percent) reported having a designated committee to review the content of school library books and make recommendations for removal. These committees consist of various combinations of school staff, division staff, parents, students (at the high school level), and sometimes the complainant. Some of these are school-level committees, while others are at the division level.

The study resolution directed JLARC to ask whether these committees include librarians and media specialists. Nearly all of the divisions with committees had either a librarian and media specialist (49 percent), librarian but not a media specialist (37 percent), or media specialist but not a librarian (12 percent) participate in the committee.

Majority of divisions maintain book removal records; few publicize meetings

About two-thirds of divisions reported keeping records about book removals. Sixty divisions (65 percent) reported they maintain information centrally about books that have been removed. However, 32 divisions (35 percent) reported they do not maintain

records. Six of these divisions that do not maintain central records reported having removed at least one book. (Five of these six divisions could not report how many book titles had been removed; one division that did not maintain central records reported information about two books that had been removed.) In addition, two divisions reported they did not know whether books had been removed.


Relatively few divisions (11) reported publicizing meetings of their review committees.

Almost two-thirds of divisions report not removing any library books, but several removed a substantial number of books

Almost two-thirds of divisions responding to the survey reported they did not remove any books from school libraries between July 2020 and March 2025. Fifty-eight divisions (63 percent) did not report removing any books based on content during the time period (excluding books that were removed because they were in poor condition or infrequently checked out). As noted above, two divisions did not know whether they had removed any books.

However, 32 divisions (35 percent of divisions responding) reported removing at least one book (Appendix B). A substantial proportion of book removals were heavily concentrated in a small number of divisions (Figure 1).

Hanover County Public Schools reported removing the most book titles (125) of any division. Rockingham County Public Schools reported removing the second most (57), but noted these removals were potentially temporary pending the approval of an updated policy. Goochland County Public Schools reported removing the third most

books (34). The five divisions that removed the most books accounted for 75 percent of all removal activity.

Library books were removed from individual schools and entire divisions. About 60 percent of all book removals were division-wide, based on school divisions who responded to the survey question about whether book removals applied to a specific school or the entire division. The remaining removals were reported across individual high, middle, and elementary schools. Most, but not all, divisions have policies that contemplate challenges being made and resolved at the school level. Many of these still require schools to inform the division when books are removed from a school.

Book removals occurred in all but one region of the state and in divisions of all sizes

Divisions removed at least one book in all but one region of the state, according to the survey. At least five divisions removed at least one book in Northern Virginia, the Northern Neck, and the Blue Ridge & Valley. No divisions in Southside Virginia responding to the survey reported removing any books (Table 1).

A division's size did not appear to be related to whether it removed books. For example, both very small divisions (fewer than 1,000 students) and very large divisions (more than 25,000 students) removed books. The state's largest division, Fairfax County, did not remove any books during the time period.

Divisions reported removing 223 unique book titles from school libraries

Collectively, divisions responding to the survey reported that 223 unique book titles had been removed between July 2020 and March 2025. Most of these book titles were removed from only one school division. Sixty-six book titles were removed by at least two divisions (Appendix C). Gender Queer: A Memoir by Maia Kobabe was removed by

the most divisions (seven) (Table 2). Accounting for the removal of the same title in multiple divisions, there were at least 344 removal actions during the time period.

Divisions and schools removed the most books during school year 2023–24—about one-third of the removal activity occurred during the time period. The second most active school year for removals was 2022–23, followed closely by 2024–25. There was very little removal activity in the 2020–21 school year.

No divisions without a book removal policy reported removing any school library books between July 2020 and March 2025. Conversely, about half of the divisions with a book removal policy did not remove any books.

Primary reasons for removal were sexually explicit content or local policy

Sexually explicit content or local policy were by far the two most prevalent reasons why divisions reported removing books. As directed in the study resolution, JLARC asked whether books were removed because of §22.1-16.8 of the Code of Virginia, which requires that schools notify parents when instructional material will contain sexually explicit content and allow them to review and request an alternative assignment. (More information on this law is available in the last section of this report.) JLARC's survey also asked whether each book was removed for a different reason. In part due to lack of central recordkeeping, not all divisions consistently reported specific reasons why individual books were removed. Divisions that cited the reason for removing books typically said they did so for one of two reasons: their own policies or state law (§22.1-16.8 on sexually explicit material). Specific reasons given for book removals included

The Code of Virginia defines sexually explicit content. §2.2-2827 stipulates that sexually explicit content means "(i) any description of or (ii) any picture, photograph, drawing, motion picture film, digital image or similar visual representation depicting sexual bestiality, a lewd exhibition of nudity, as nudity is defined in §18.2-390, sexual excitement, sexual conduct or sadomasochistic abuse, as also defined in §18.2-390, coprophilia, urophilia, or fetishism."

- §22.1-16.8 of the Code of Virginia (instructional material; sexually explicit content) (sidebar)
- "Sexually explicit content"
- "Division regulation"
- "Local policy"
- "No longer supported by district policy"
- "Determination of developmental inappropriateness"
- "Anti-religious"
- "Recommended for removal by board member"
- "Vulgar language"

State provides minimal guidance about library book challenges; divisions had mixed opinions about benefits of more state guidance

The study resolution directs JLARC to identify state-level resources available to divisions about making decisions to remove library books. VDOE's website includes a "Library & Media Services" page, which includes links to relevant laws and regulations regarding libraries, but none specifically address library book challenges. However, VDOE reports that staff are available upon request to help librarians if they need assistance. VDOE indicated that the most frequent questions they receive from school divisions about libraries are typically related to librarian qualifications rather than about guidance on school division book removals.

When asked, divisions who responded to the JLARC survey had mixed opinions about whether they needed the state to provide additional guidance or information about book removals. Relatively few (13 percent) divisions believed they could "greatly" benefit from additional guidance from the state on decisions about removing school library books. Most divisions reported they could benefit "somewhat" (43 percent) or "very little" (33 percent). The remaining divisions (11 percent) reported they would not benefit at all. (There was a slight tendency for smaller divisions to report more frequently that they could greatly benefit from additional guidance; eight of the 12 divisions that said they could greatly benefit from additional state guidance had fewer than 3,800 students—the median number of students for responding divisions).

Statute cited as reason for removing many books not applicable to school library book removal; yet divisions have discretion over books

As noted above, divisions that removed books frequently cited §22.1-16.8 of the Code on the JLARC survey as a reason why a book was removed. The 2022 law requires school divisions to develop a policy to ensure parents are notified when sexually explicit material will be taught and allows any parent to review the material and request

alternatives to such material for their child or children (sidebar). VDOE was directed to issue model policy guidance, which it did. The 2022 law applies to library books that meet VDOE's definition of instructional materials, such as those used for a classroom assignment.

However, the law does not indicate that any instructional materials or other books including sexually explicit content should be removed from school libraries. The law does not include the words "library" or "remove." Moreover, the final bill includes an enactment clause that clearly indicates it was <u>not</u> the General Assembly's intent for this law to apply to removing books from school libraries. The enactment clause states, "that the provisions of this act shall not be construed as requiring or providing for the censoring of books in public elementary and secondary schools."

Two factors may have contributed to the incorrect citing of the 2022 law by some divisions as the reason for removing a book. First, because the enactment clause is in the final bill but not the legislation text in the online Code of Virginia, division or school staff who refer to the legislation text online may not be aware of the enactment clause expressly stating legislative intent. Second, in an attempt to clarify broader confusion about the 2022 law, VDOE released superintendent's memo #108-23 in June 2023: Clarifications on School Library Management. The memo re-states the provisions of §22.1-16.8 and provides some additional information about instructional materials but does not specifically address or clarify that §22.1-16.8 is not applicable to removing books for all students or from libraries.

The practical effect of this may be minimal given that divisions already have discretion over the selection of library materials and their library book removal policies. However, it may be useful (at least for some divisions) for VDOE to more directly clarify that the 2022 law does not apply to removing school library books.

Partially in response to §22.1-16.8, some divisions report giving parents options related to library books. For example, some school divisions allow parents to request that their child not be able to check out certain books from the school library. Others will inform parents of books their children check out.

Appendix A: Study resolution

SENATE JOINT RESOLUTION NO. 251

Directing the Joint Legislative Audit and Review Commission to study the removal of certain books from public school libraries. Report.

Agreed to by the Senate, January 29, 2025 Agreed to by the House of Delegates, February 20, 2025

WHEREAS, the libraries in the Commonwealth's public schools are an important source of learning and exploration for students in the Commonwealth; and

WHEREAS, the books in circulation in the libraries of the Commonwealth's public schools are selected and curated by professionally trained school librarians and media specialists; and

WHEREAS, there are times at which some parents of public school students object to the inclusion of certain books in public school libraries while other parents support or approve the inclusion of such books in public school libraries; and

WHEREAS, § 22.1-16.8 of the Code of Virginia was enacted by the 2022 Session of the General Assembly for the purpose of directing the Department of Education to adopt model policies, and each school board to adopt policies consistent with but that may be more comprehensive than such model policies, for ensuring the parental notification of any instructional material that includes sexually explicit content, as that term is defined in applicable law, and to provide parents the opportunity to request their children be provided, as an alternative, nonexplicit instructional material; and

WHEREAS, the Department of Education adopted the model policies required pursuant to § 22.1-16.8 of the Code of Virginia in August of 2022, which focused on books used in the classroom and specifically clarified that any books contained in public school libraries would, under such policies, be considered "instructional material" only if students were required to read such books for completion of an assignment or as a part of an academic or extracurricular educational program; and

WHEREAS, some school divisions subsequently removed books from circulation in public school libraries based on the school division's determination that such books contained sexually explicit content, in accordance with § 22.1-16.8 of the Code of Virginia, or based on the school division's determination that other content contained in such books was objectionable; and

WHEREAS, some of the decisions by school divisions to remove certain books from public school libraries were made upon the recommendation of "challenge committees," consisting of parents of students in the school division and school librarians or other media specialists, while in other cases, such decisions were made without any recommendation of a school librarian or media specialist and were, instead, made upon the direction of a school board, individual school board members, individual school principals, division superintendents, or other school administrators; and

WHEREAS, the variations in procedure, process, and standards for the removal of certain books from public school libraries by school divisions across the Commonwealth presents significant questions relating to compliance with § 22.1-16.8 of the Code of Virginia and the protection of the opportunities for learning and intellectual exploration created by public school libraries; now, therefore, be it

RESOLVED by the Senate, the House of Delegates concurring, That the Joint Legislative Audit and Review Commission be directed to study the removal of certain books from public school libraries. The Joint Legislative Audit and Review Commission shall focus its study on any books removed from public school libraries after July 1, 2020, based on certain content included in such books.

In conducting its study, the Joint Legislative Audit and Review Commission shall survey each of the 135 school divisions in the Commonwealth to identify (i) which school divisions removed any books from a library in any of its public schools on the basis of certain content contained therein after July 1, 2020; (ii) for each removed book identified pursuant to clause (i): (a) the title, author, and any other identifying information; (b) the fiscal year of removal; (c) the name of the school from whose library such book was removed; (d) whether it was removed upon the recommendation of a "challenge committee" and, if not, whether it was removed at the direction of the school board or one or more school board members, a school principal, a division superintendent, or another school administrator; (e) how the review was initiated, the role of the school's librarian or media specialist in the removal process, and which, if any, other school board employees were involved in the removal process and the role each individual played; and (f) if § 22.1-16.8 of the Code of Virginia or a policy adopted in accordance therewith was used to justify such removal; (iii) which school divisions have appointed a committee or other body to review the content of books currently contained in or proposed book purchases for inclusion in public school libraries and, if so, whether (a) such committee or body includes a [school] librarian or media specialist employed by the school division and (b) the meetings of such committee or body are advertised and open to the public; and (iv) in consultation with any relevant state agencies, what resources are available at the state level to support school administrators in making decisions relating to the removal of books from public school libraries.

Technical assistance shall be provided to the Joint Legislative Audit and Review Commission by local school divisions in the Commonwealth. All agencies of the Commonwealth shall provide assistance to the Joint Legislative Audit and Review Commission for this study, upon request.

The Joint Legislative Audit and Review Commission shall complete its meetings by August 1, 2025, and the chairman shall submit to the Division of Legislative Automated Systems an executive summary of its findings and recommendations no later than October 1, 2025. The executive summary shall state whether the Joint Legislative Audit and Review Commission intends to submit to the General Assembly and the Governor a report of its findings and recommendations for publication as a House or Senate document. The executive summary and report shall be submitted as provided in the procedures of the Division of Legislative Automated Systems for the processing of legislative documents and reports and shall be posted on the General Assembly's website.

However, divisions were less likely to respond if they had about 1,000 to 3,500 students. Divisions in the Central Virginia and Blue Ridge & Valley regions were more likely to respond than divisions in other regions.
